- Mapped multi-step login sequences involving **MFA** prompts, rotating **cookies**, CSRF tokens, and session expiration, then documented approved recovery paths for support teams.

- Delivered **Python** automation for legal and insurance portals using Selenium, **BeautifulSoup**, requests, and Playwright prototypes to extract structured case and account information.
- Investigated HTTP **headers**, redirects, cookies, and browser **network calls** to resolve authentication failures and distinguish rendering defects from source-system errors.
- Created fault-tolerant task runners with exponential backoff, checkpointing, duplicate detection, and actionable logs for recurring extraction schedules.
- Integrated REST endpoints and **XML** feeds with browser-derived records, applying schema validation and transformation rules before delivery to internal data services.

- Parsed HTML, **JSON**, and XML responses into normalized records used by analysts evaluating vendor and customer portal data.
- Added cookie persistence, header configuration, timeout handling, and clear exception messages to stabilize extraction tools against inconsistent web responses.
- Wrote pytest **unit tests** for parsers and transformation functions, then incorporated test execution into the team's initial CI pipeline.
- Packaged repeatable local environments with **Docker** and maintained setup documentation for developers testing headless browser behavior.
- Assisted with an AWS proof of concept using S3 and Lambda, presenting findings on execution limits, logging needs, and practical scaling considerations.
